Evaluation of the project "Sport for all Genders and Sexualities - Tackling Sexism, Trans- and Homophobia in European Grassroots Sport" (SGS), Project Number "101050101 — SGS"; Project Duration: 1 April 2022 – 30 September 2024 (30 month)

Summary

Appointment of an international evaluator for the execution of the evaluation of the European Commission funded project "Sport for all Genders and Sexualities - Tackling Sexism, Trans- and Homophobia in European Grassroots Sport" (SGS) according to the guidelines laid out by the European Commission.

The project is implemented by Vienna Institute for International Dialogue and Cooperation (VIDC, Austria, lead agency). Partners in the project are German Sports University (GSU, Germany), European Gay and Lesbian Sport Federation (EGLSF, The Netherlands), Assoziazione Italiane Cultura e Sport (AICS, Italy), Diversport (DS, Spain), Landessportbund Nordrhein-Westfalen (LSB, Germany) and Confédération Sportive Internationale Travailliste et Amateur (CSIT, Austria).

Output of the Evaluation

An evaluation report (max 30 pages, English) and executive summary (max 3 pages)

The evaluators should meet following requirements:

- being independent from the organisations implementing the project
- being experienced in evaluations of awareness raising/advocacy/campaigning projects or similar projects/actions in the field of sport and anti-discrimination
- being fluent in English and able to write the evaluation report in decent English

Evaluating of the project outcomes:

An external evaluation will be commissioned that will work on central modules of the project over the entire project period. All 5 Workpackages will be observed in the methodology of external evaluation. Taking as reference the guidance from the European Commission for the evaluation of projects, a participatory evaluation approach should be employed.

The following evaluation objectives are established:

- i) Assessment of the objectives to be achieved by the project.
- ii) Assessment of the operational objectives anticipated by the planned actions/activities.
- iii) Assessment of the added value for grassroots sports and gender diverse athletes (impact of actions).

Relevance, adequacy/effectiveness, and impact/efficiency are considered as evaluation criteria for the planned actions, with a view to the main achievements of the "Sport for all Genders and Sexualities" project objectives.

For the operationalization of the evaluation criteria, the following is considered:

- Relevance of the implementation of designed actions. The specific objectives of each Workstream action and the extent to which each one contributed to the achievement of the overall objective of the "Sport for all Genders and Sexualities" project, that is to enhance the inclusion and participation of all genders and sexualities in European grassroots sport through understanding barriers and institutional exclusion, establishing institutional dialogue, developing guidelines for grass roots sport, awareness raising campaigning and training to tackle these discriminations and diminish barriers for transgender athletes, LGB people and women.
- Adequacy and efficacy of the designed Workstream actions in achieving the desired or expected results for each one; the extent to which each action was suited to the operational aims defined for each Workstream in particular.
- Impact and efficiency of the "Sport for all Genders and Sexualities" project results. These
 evaluation criteria concern various aspects of how the resources are transformed into the
 intended results, and could be achieved by the assessment of resources and trainings.

Proposals for an evaluation concept are asked to include the collection of the following information:

- i) <u>Interviews</u> among the project partners to collect data about the implementation of each phase by Workstream actions (empirical material collected, methodologies, results, outputs and recommendations; online tools, events, organisations and participants/stakeholders involved, media impact, and dissemination of information, etc.);
- ii) <u>Attendance and observation</u> of activities and interviews with target groups, especially clubs and initiatives at the grassroots to feedback impact of measures and suitability;
- iii) (Online) Questionnaire survey conducted among target groups (sport clubs/migrants/initiatives at the base/participants/stakeholders) for each of the planned milestone events to gain feedback ("feedback forms");
- iv) <u>Qualitative analysis of gained knowledge/experiences</u>: Assessment of need in the field, research, training tools, publications to raise awareness and training tools to enhance institutional inclusion of alle genders and sexualities.

Ensure any relevant guidance from the European Commission, including that relating to structure and content of the evaluation is followed.

The evaluator can expect the following from the project implementing partners:

- liaising with the evaluator initially (via Zoom, MS Teams or Skype)
- supporting the evaluator to develop a plan of action
- opportunities to be interviewed

- sharing feedback forms/online questionnaire online among stakeholders and beneficiaries to gain feedback
- access to venues and local travel arrangements
- providing evidence and monitoring data
- providing contacts for interviews
- assistance in editing the final evaluation
